The following personal data are collected: Obligatory fields include name, surname and email address of the participant, as well as name of organisation (including the shorter version to be used for the conference badges) with business address/details. It is not obligatory to provide a job position, business mobile phone, or upload a picture. The

Your data will be kept for a maximum period of **18 months** after the end of the event. Data will be automatically deleted at the end of this period.
